CREDENTIAL COURSES AND EXAMS

HACCP Manager Certification Course

Students will take a nationally recognized HACCP Manager Certification Exam at the end of the course. Cost is \$249 for members and \$299 for nonmembers. Prerequisite: minimum of CPFM certification recommended. *Limit 50 people.*
